Christmas Trees - 2016 Crop is Good, Future Crops Hurt by Drought

Christmas tree purchasers will find plenty of good mature trees to use this holiday season, but the ongoing drought has made it difficult for growers to get replacement seedlings to survive.

About 400 farms around Massachusetts grow Christmas trees, primarily for retail sale during the 5 week season from Thanksgiving to Christmas. Christmas tree sales add about \$1.4 million to the Massachusetts economy, according to the Massachusetts Department of Agricultural Resources. Trees take between 7 and 12 years to grow to maturity here, so trees being harvested this year were planted between 2004 and 2009. To ensure a sustainable harvest, growers need to replace trees harvested each year with new seedlings.

The severe drought which has affected Massachusetts for the past two years has not greatly reduced the number of trees available for sale now as mature trees have well-established root systems, but growers have reported near total mortality of new seedlings planted in the last two years.

New State Contract will Promote Sales of Locally Produced Wood

The DCR 728 Contract is an opportunity for businesses to sell local wood products from sustainably managed forests within Massachusetts directly to the Commonwealth, municipalities, and other eligible organizations. Its main role is to set up the framework

for businesses to connect with local public entities to meet resource needs with products sourced from local forests.

Products eligible to be sold under the contract include, but are not limited to: lumber, structural lumber under either the Massachusetts Native Lumber Program or NELMA, as well as manufactured goods like bowls, flooring, millwork, and sheds.

In addition, the contract allows for businesses to play a role in processing wood for the Commonwealth for services such as portable milling, kiln drying, and other forms of value adding.

New Study Shows Greenhouse Gas Benefits of Switching to Pellet Heat

A study released by the Northern Forest Center in October shows that switching to burning wood pellets for heat cuts greenhouse gas emissions by 50 to 60 percent over oil and natural gas.

The study, conducted by the Spatial Informatics Group—Natural Assets Laboratory, used data specific to the region's forest composition and harvesting practices, and assumed that pellets were sourced from and manufactured in the Northeast.

The life cycle study found that burning wood pellets for heat reduces greenhouse gas emissions immediately by 54 percent compared with burning oil, and by 59 percent compared with burning natural gas. The study also found that, over a 50 year time period, greenhouse gas reductions from burning pellets would cut emissions 62 percent over oil and 67 percent over natural gas.

New Publication Highlights Forest Resiliency for a Changing Climate

How will our woodlands change over the next 100 years? Will they be transformed by warming temperatures, or lose species to invasion by non-native plants or insects? Will they become more susceptible to weather events or lost to development?

Those are questions addressed by a new publication developed by researchers from the Universities of Massachusetts, Vermont and the U.S. Forest Service called, *Increasing Forest Resiliency for an Uncertain Future.* In the 32 page publication, Paul Catanzaro of UMass, Anthony D'Amato of UVM, and Emily Silver Huff from the Forest Service discuss the likely impacts of climate change, invasive pests, and development on our woodlands and ways to lessen their impacts.
